



1.0 Under-Graduate Degree Programme in Engineering & Technology (UGP in E&T) Sreyas Institute of Engineering and Technology, an Autonomous Institution affiliated to Jawaharlal Nehru Technological University Hyderabad (JNTUH) offers a 4-year (8 semesters) Bachelor of Technology (B.Tech.) Degree programme, under Choice Based Credit System (CBCS) with effect from the academic year 2022-23.


## B.Tech. Programme Structure
