Member Secretary explained the status of admissions (2023-24) and why reduction of intake both in Mechanical Engineering and ECE reduced for the A.Y.2024-25. Further as per the current demand for the new courses he suggested going for increasing in existing branches and starting new courses. The Governing Body Members approved the resolution.

The details are as Follows.

- (i) Reduction in intake B.Tech. Mechanical Engineering Programme intake from 60 to 30 and B.Tech Electronics and Communication Engineering Programme from 120 to 60 from Academic year 2024-25
- (ii) Increase in intake B.Tech. CSE from 240 to 540, increase in CSE (AI&ML) from 180 to 360 and increase in CSE (Data Science) from 150 to 180 from Academic Year 2024-25 or CSE (Data Science) with intake of 180 will merge with CSE.
- (iii) New Courses: Introduction of new Programmes BCA and BBA from Academic year 2024-25.

Suggestions given by the Governing Body Members

Chairman of Governing Body:

Mr.A.Vinay Kumar Reddy conveyed greetings to all Governing Body Members. He also agreed with every recommendation made by the members of the Governing Body.


